Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries.

To date, close to 150,000 officials from more than 180 countries, territories, and intergovernmental organisations have participated in our courses and study visits. The SCP is managed by the Technical Cooperation Directorate of the Ministry of Foreign Affairs, Singapore.

Course Objectives

This in-person course is conducted under the auspices of the Singapore Cooperation Programme Training Award (SCPTA).

Centered around the Singapore Liveability Framework, this course will equip participants with the knowledge and skills required to manage technologies against the backdrop of changing economies, ecological and social systems to build a smart and sustainable city.

Synopsis

Topics to be covered include:

- Integrating technologies with changing economies, ecological and social systems.
- Environmental management through smart modelling and public engagement.

Methodology

The course will be conducted in-person in Singapore and will include the delivery of instruction of course sessions, case studies as well as group discussions.

Course Duration

The course will be conducted daily from 18 to 22 March 2024 in Singapore.

Application Information

Applicants should be:

- Mid- to senior-level officials who are involved in policymaking for urban development and smart city development;
- Nominated by their respective Governments;
- Proficient in written and spoken English; and
- In good health.

Course Sponsor

The online course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.

Regulations

Participants are required to comply with the following:

- Strictly observe course schedules and not miss training sessions; and
- Carry out instructions and abide by conditions as may be stipulated by the nominating authority or government and the Government of Singapore and its appointed trainer, with respect to the course.

Terms of Award

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.

Under this programme arrangement, the Government of Singapore will bear the following expenses for the successful applicants (thereafter known as participants) during their training in Singapore. These expenses include:

- Course fees:
- Hotel accommodation for the entire duration of the course. Complimentary breakfast is provided in the hotel from the first day of the course to one day after the course;
- A daily training allowance of One Hundred and Twenty Singapore Dollars (S\$120) from the first day to the last day of the course. A proportionate reduction in the daily training allowance will be made if you are unable to attend the full duration of the course;
- · Transportation between hotel, training venue and site visits; and

Basic insurance coverage (Group Hospitalisation and Surgical; Group Personal Accident) for participants during their stay in Singapore, in accordance with the policy of a local insurance company. - Participants are to bear their personal expenses that might be incurred prior to receiving the allowance: and
- As the basic insurance coverage is limited, participants are strongly advised to purchase comprehensive travel insurance which includes adequate coverage of COVID-19 related expenses and medical evacuation in the event of any unexpected emergencies.

Participants are required to comply with the following:

- Strictly observe course schedules and attend all training sessions; and
- Carry out instructions and abide by conditions as may be stipulated by the nominating Authority or Government and the Government of Singapore and its appointed trainer, with respect to the course.

Application Procedure

The Government of Singapore is pleased to invite the respective National Focal Point for Technical Assistance (NFP) to nominate 1 suitable applicant. Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective NFP in the event that its nominee(s) is not selected.
